#### **Results Service**

Students will receive their results in school for the November 2023 series on 1st February. If a student is absent, parents can collect their results at the School Office from 11:30am. Results cannot be given over the phone or email. If a student continues to be absent, remaining results will be posted on the afternoon of Monday 5th February.

The CCEA Post-Results Service for this series will open between 2<sup>nd</sup> – 23<sup>rd</sup> February. To order **Options 1 - 6**, students should **print the paper form overleaf and return to Mr Wright in Room 2 by the dates below.** Please pay with exact change to secure your order.

### Defining a 'Review of Marking'

This is a review of the original marking to ensure that the mark scheme has been applied correctly. A marking error can occur because of:

- an administrative error;
- a failure to apply the mark scheme where a task has only a 'right' or 'wrong' answer; or
- an unreasonable exercise of academic judgement.

An academic judgement is what is involved when assessing. It is possible for different examiners reasonably to reach different judgements. Unreasonableness in academic judgement occurs where the mark given is one that no reasonable examiner could properly have awarded.

Reviewers will not re-mark the script. They will only act to correct any errors identified in the original marking.

## A Centre (School) Review of Marking

In the unlikely event that the school has concerns about the marking of an entire cohort (or a large section of it), it will then submit a *centre review* of marking for **all** candidates it believes to be affected. The school will enter into dialogue with parents before activating this process to ensure this action has your support.

The school must submit to CCEA clear evidence to support its application in these cases and therefore we will only request a centre review if appropriate evidence is available and a change of grade is likely.

In cases where centres and candidates, or their parents/carers, cannot agree as to whether a *centre review/appeal* of results should be requested, the school will retain the decision based upon available evidence and the likelihood of a final grade change.
